Job Summary:	Reporting to the Chief Hospital Administrator, this position supports the Animal Society in achieving the mission and vision through driving the goals and achievements of the Sam Greer Spay/Neuter Clinic, Simon Greer Mobile Spay/Neuter Clinic. The primary focus will be ensuring spay/neuter goals are met through the daily sterilization of all surgical patients. The quality of patient care is first and foremost. This also includes the maintenance of preventive health programs and medical protocols and ensuring clinic staff are adhering to the proper peri-operative care of the patients. Must be open to periodically working on the spay/neuter mobile unit which will travel throughout the state of South Carolina. The ideal candidate will be a person of integrity, loyalty, and who has the capacity for hard work, perseverance, and resiliency.			
Key Responsibilities:	1. Preforms efficient and effective high-volume, high-quality (HVHQ) spay and neuter aiming at approximately 3,800 or more spay and neuter procedures annually. (Primary Focus; Human Alliance Model).			
	2. Examine animal pre-op to determine their ability to undergo surgery.			
	3. Examine animals, supervise post-op rechecks, and oversee order of medical treatments as necessary to			
	ensure complete surgical recovery.			
	4. Inoculate animals and provide recommendations for follow up care (this may consist only of referring			
	client/patient to their regular veterinarian if an owned animal).			
	5. Supervise cleaning program for prevention of infectious/zoonotic disease.			
	6. Continue research and maintenance of safe and efficacious medical protocol regarding anesthesia and surgery.			
	7. Supervise handling and recording of controlled substances by Medical Records Technicians.			
	8. Actively promote spay and neuter, and educate clients on responsible animal ownership.			
	9. Actively support associate staff and volunteers, and promote the development of skills related to the			
	advancement of our goals and mission.			
	10. Mentor and teach veterinary students and visiting veterinarians in the tenants of spay/neuter and shelter medicine.			
	11. Represent the Charleston Animal Society in a professional and courteous manner at all times.			
	12. Provide quality service to clients, volunteers, and staff recognizing their individual contributions to the success of our organization.			
	13. Participate on committees and special projects as assigned.			
	14. Other duties as assigned.			
	OTHER DUTIES AND RESPONSIBILITIES:			
	 Effectively "team lead," displaying a positive attitude and acting as a motivating force for all staff members. Provide input and communicate any issues regarding the clinic's disease control protocols, surgical protocols, or other medical issues at regular Veterinarian meetings or with the Chief Veterinary Officer. Ensure clinic staff members are adhering to proper peri-operative care of patients. Communicate any issues concerning staff or patients with Clinic Veterinarians. Provide medical and/or surgical support for animals within the Society's sheltering system under the 			

5. Provide medical and/or surgical support for animals within the Society's sheltering system under the direction of the Chief Veterinary Officer and with the support of the Clinic Directors.

1. Client Education:

- a. Must also be able to communicate basic veterinary concepts to owners and be able to repeat information relayed by other veterinarians.
- b. Will be asked to take medical histories for surgical rechecks.
- c. Communicate with the public on a daily basis in a professional manner, if needed.

2. Animal Handling:

- a. Will be asked to handle (on average) 50 dogs and/or cats per day. Occasionally other species.
- b. Must be able to learn characteristics of animal behavior (for example: be able to identify aggressive or fearful behavior).
- c. Must be able to use appropriate safety equipment for fractious or feral animals the use of safety equipment is mandatory.
- d. Must possess excellent reflexes.
- e. Should be able to identify own limitations and be willing to ask for help.
- f. Must become proficient at animal restraint for various procedures.

3. Physical Requirements:

- a. Must be able to work standing or sitting for 8 or more hours.
- b. Able to lift and carry up to 50 lbs repeatedly throughout the day with help.
- c. Must be able to bend and kneel repeatedly.
- d. Must be able to see fine detail in a variety of situations.
- e. Must have adequate hearing including ability to distinguish changes in pitch.
- f. Must have reasonable degree of agility to move through tightly cramped areas in various situations.
- g. Must have acceptable sense of touch and smell.
- h. Must have good range of motion in joints especially wrist, knees, elbows.
- i. Must have good range of motion in your back for instance twisting.
- j. Must be able to work in potentially extreme environmental temperatures.
- k. Must have acceptable sense of balance.
- 1. Must be able to work and reach on hands and knees.
- m. Must possess excellent hand-eye coordination.
- n. May be asked to move large oxygen tanks.
- o. Must possess an acceptable degree of dexterity in hands and fingers.
- p. Must have good vision including peripheral vision, fine detail, distance, depth perception and ability to focus.

4. Other Requirements:

- a. Able to respond quickly to a variety of medical situations (with training).
- b. Able to cope with death either due to surgical complication or euthanasia.
- c. Ability to rapidly and accurately process information.
- d. Ability to delegate tasks.
- e. Ability to cope with frustrating situations and remain calm.

5. Potential and Prolonged Exposures:

- a. Prolonged exposure to various aqueous solutions including but not limited to dish soap, chlorhexidine and Rescue disinfectant.
- b. Prolonged exposure to isopropanol, hydrogen peroxide.
- c. Potential exposure to formalin solution.
- d. Potential/Prolonged exposure to isoflurane gas.
- e. Prolonged exposure to quartenary ammonium cleaners and bleach.
- f. Prolonged exposure to pressurized steam.
- g. Potential exposure to sharps including needles and surgical blades.

Qualifications:

- Must be a licensed Veterinarian in the State of South Carolina.
- Prefer a minimum of 3-5 years of proven veterinary and surgical experience in High Volume, High Quality (HVHQ) Spay/Neuter practice or shelter and success in working with a solid team.
- Must thrive in a multi-tasking, fast paced and dynamic environment.
